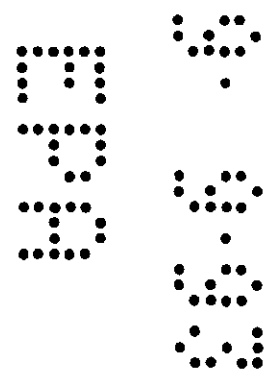

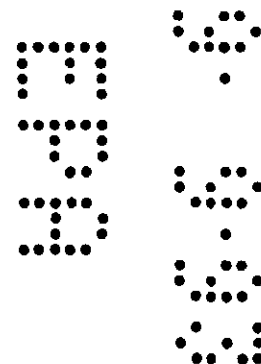

The maker of Raid guarantees that Raid Roach Bait III works or your money back.

This is how Raid Roach Bait III works:

1. Baits (discs) (killers) (tunnels) fit snugly against walls, where roaches commonly travel.
2. Roaches are attracted to the bait(s) (discs) (killers) (tunnels) to feed.
3. Roaches eat (in) the bait (discs) (killers) (tunnels) and crawl away to die.



DIRECTIONS FOR HOUSEHOLD USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

1. (To remove baits (discs) (killers) (tunnels) from the tray, place both thumbs on the label of each bait (disc) (killer) (tunnel) and push out.) (Break bait (disc)(killer) (tunnel) apart from plastic frame.) (Lift baits (discs) (killers) (tunnels) from the plastic tray.)

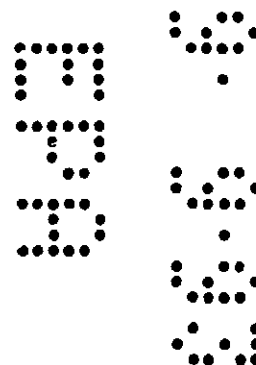
1. Remove the baits (discs) (killers) (tunnels) from box (and) (activate as shown) (pull the tab seal to activate) (close lid) (slide unit into place) (snap into place).

2. For thorough roach control, use all (6-24) baits (discs) (killers) (tunnels) at one time. Place at least (5-20) baits (discs) (killers) (tunnels) in the kitchen and (1-2) in each bathroom. **FOR LARGER KITCHENS OR PARTICULARLY HEAVY INFESTATIONS**, we strongly recommend using additional baits (discs) (killers) (tunnels) and placing at least (8-24) baits (discs) (killers) (tunnels) in the kitchen and (2-4) in each bathroom. (If you see roaches in other areas, such as the bedroom, or (pantry,) utility room, (garage, or basement,) use additional baits (discs) (killers) (tunnels).) Place baits (discs) (killers) (tunnels) in areas where you have seen roaches. Roaches are often seen near water or food sources in areas such as the kitchen, bathroom, pantry, utility room, garage, basement, or near exposed plumbing fixtures, windows and doors.

3. For best results, place the baits (discs) (killers) (tunnels) on the floor along baseboards, in corners, under sinks, in cabinets and near plumbing fixtures. You can even place Raid Roach Bait III on kitchen countertops and next to food.

4. Use the enclosed tapes to hold the baits (discs) (killers) (tunnels) in place when using them (upside down,) inside drawers or underneath countertops. You will not find it necessary to use tapes for all the baits (discs) (killers) (tunnels).

5. 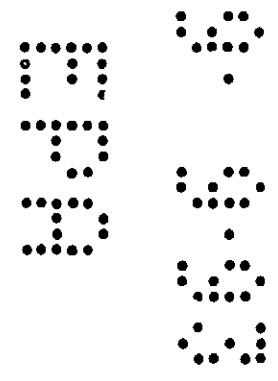

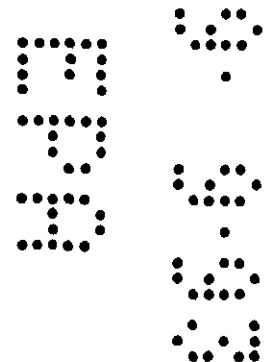
