

DIRECTIONS FOR USE

Hold container 6 to 8 inches from skin or clothing and spray with a slow sweeping motion. Do not use as a space spray. Use just enough repellent to cover exposed skin. Avoid overexposure. Frequent reapplication and saturation are unnecessary. Do not keep product on any longer than necessary. After returning indoors, wash treated skin with soap and water.

On behalf of S.C. Johnson & Son, Inc., I am submitting a notification for the above-mentioned product. We will be adding the phrase:


Contains DEET (N,N-Diethyl-meta-toluamide)
