4. Regarding the **Confidential Statement of Formula (CSF)**: The Lower Certified limit (column 14b) for the formulation component DEET must be lower than the nominal concentration (column 13b). Revise the CSF and resubmit this document for the record.
5. Submit one (1) copy of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

Insect Repellent 1994 DJDS is effective, dependable protection that does not feel greasy or oily. It won't stain and resists perspiration. It has a fresh, clean (baby powder fresh) fragrance that won't leave you smelling like a bug repellent. Keeping insects away never felt so good.

Hold container 6 to 8 inches from skin or clothing and spray with a slow sweeping motion. Do not use as a space spray. Use just enough repellent to cover exposed skin. Avoid overexposure. Frequent reapplication and saturation are unnecessary. Do not keep product on any longer than necessary. After returning indoors, wash treated skin with soap and water.

To apply to face: Spray palm of hand and rub on. Do not apply to eyes and mouth and do not apply to the hands of young children.

For maximum protection, spread evenly with hand to moisten all exposed skin.

**WORKS ON CLOTHING TOO:** Spray shirts, pants, socks, and hats. For chiggers also spray cuffs, socks and around other openings in outer clothing. Wash treated clothing. Do not apply under clothing.
