1. Page 1 and 2:

- a. Place the following statement in the First Aid section: "For additional information free(Insert phone number)."
- b. Add the statement: "Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals." to the Precautionary Statements.
- c. Remove the following Unacceptable disease vector claims:
 - i. Mosquitoes
 - 1. Encephalitis
 - a. Japanese
 - b. Venezuelan equine
 - c. Murray Valley
 - 2. Ross River Fever
 - 3. Barmah Forest Disease
 - 4. Dengue Fever
 - 5. Yellow Fever
 - 6. Rift Valley Fever
 - 7. Malaria
- d. Revise the following marketing claim as it contains a single active ingredient "Insect Repellent 1994 DJDS is specially formulated with a lower level of active repellent ingredients to feel and smell better on your skin."
- e. Revise the statement "Inert Ingredients" within the ingredient statement to "Other Ingredients"
- f. Within the "Hazards to Humans" section, revise the statement "Wash thoroughly with soap and water after handling." To "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco"¹

2. Page 2:

- a. Within the First Aid section, remove the word "Skin:" from the "If you suspect a reaction to this product,.....for treatment advice."
 - b. Within the section entitled "TO APPLY TO FACE", move the following DEET statements "Do not apply to children's hands." and "When using on children, apply to your own hands and then put it on the child." to the previous paragraph directly above. The DEET RED document does not limit this language when applying to the facial area only.
 - c. Add the required header "Storage and Disposal" directly above the Storage and Disposal section.² In addition, revise the sentence "Do not reuse this container" to "Do not reuse or refill this container."
3. To be eligible for reregistration, aerosol and pump spray formulations must be packaged in containers utilizing a concave trigger to help aim product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.
4. The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised



guidelines.

5. FIRST AID:
