(approx. 15' x 19' x 8'). One (name) mat lasts ten hours. (Name) mat turns white when active ingredient has been exhausted. To change mat: unplug heater, turn upside down and allow (name) mat to fall out. For indoor use only when mosquitoes and/or flies are an annoyance. Do not use in rooms while people are sleeping.

Storage: Store in original container and keep in locked area. Disposal: Unplug heater and turn upside down to allow (name) mat to fall out. Securely wrap mat in several layers of newspaper and place in trash. Do not reuse container. Discard container in trash.
