Raid Flea Killer Plus Carpet Spray II is designed for use whenever a flea (bug) infestation(s) occur(s) in your house. For a complete flea control program, or for particularly heavy flea infestations, use Raid Flea Killer Plus Carpet Spray II in conjunction with other Raid Flea Killer Plus products (Dog Spray, Fogger, Yard Spray).

SHAKE BEFORE USE. Point valve away from face and press button.

DIRECTIONS FOR USE: It is a violation of federal law to use this product in a manner inconsistent with its labeling.

FOR USE INDOORS: To kill fleas and ticks hold can 2-3 feet from surfaces to be treated. Be sure to apply thoroughly and uniformly using a sweeping motion, to rugs, carpets, drapes and all surfaces of upholstered furniture.

- 1) If used on light or delicate fabric, test in an inconspicuous place pricr to use. Avoid wetting furniture and carpets.
- 2) Treat under and around furniture if pets frequently rest in these areas. Repeat as necessary.

(The following italicized section is additional use directions for surface application rates that may be used if label space permits.

IMPORTANT: Only complete coverage of carpets, upholstery and curtains will insure flea control. Treat surfaces uniformly from one end of each room to the other. Apply spray uniformly to floor surfaces.

FOR USE IN PET AREA: Treat pet bedding and other pet resting areas as these are primary hiding areas for fleas and ticks. No need to remove pet bedding after treatment. Follow directions as for other indoor areas. For best results pets should be treated before they return to the treated area.

FOR USE ON DOGS: To control fleas on dogs, hold can upright, 10-12 inches from pet. Starting at the tail stroke against the lay of the hair spraying the parted fur directly behind the hand to insure penetrating the coat. Wash hands after application. Spray to slightly dampen all areas of the fur. Avoid spraying the animal's head. Do not treat puppies under 6 weeks old. Do not apply this product more frequently than once every 2 weeks

TO KILL: Roaches, waterbugs, silverfish, crickets, spray hiding places such as baseboards, pipes, behind bookcases, cabinets and other storage areas hitting as many insects as possible. Repeat as necessary.

TO KILL: Ants, centipedes, spiders, sowbugs, carpet beetles, apply directly to as many as possible.

STORAGE: Store in a cool, dry area inaccessible to children.

DISPOSAL: Do not reuse container. Wrap container and discard in trash.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Avoid contact with skin or clothing. Do not remain in enclosed areas after use. Wash hands after treating pets. Avoid contamination of food and foodstuffs. Remove pets, birds and cover and turn off fish aquariums before spraying.
