DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

TO KILL FLEAS, FLEA LARVAE, AND FLEA EGGS:

- 1. Use 8 oz. for each 100 square feet of carpet to be treated.
- 2. Make sure carpet is dry before using. Sprinkle Raid D.O.B. lightly over area by shaking container from side to side. Do not allow powder to become wet. If powder adheres to spot, brush it out and vacuum immediately. For best results, drive the powder deep into the carpet by brushing lightly with a broom.
- 3. Wait one hour, vacuum as usual. Waiting two or three hours may be required for severe infestations. Remove bag from vacuum, wrap, put in trash collection.
- 4. A second application of Raid D.O.B. 7 days later is recommended to continue controlling severe infestations.

STORAGE AND DISPOSAL

STORAGE: Store in cool dry area.
