- d. Following the paragraph indicating where the product can be used add "Do not use in food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed.".
- e. Under Precautionary Statements replace "Keep out of treated area for one (two)(three)(four)(five)(six) hour(s)." to "Keep out of treated area for four hours.".
- g. Following "Extinguish all flames and pilot lights" add "Call your gas utility or management company if you need assistance.".

Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).
2) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. Extinguish all flames and pilot lights. Do not use fogger in a cabinet or under a counter or table. Use only one can in rooms 12' X 12' or smaller.
3) Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper or paper towels.
4) Break off and remove tab on side of sprayer. Tilt sprayer AWAY from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place.
5) Set fogger on covered stand. Immediately leave treated area.

6) Keep treated area closed for at least one (two) (three) (four) (five) (six) hour(s). Before reoccupying area, open all doors and windows and allow treated area to air for 30 minutes.

## STORAGE & DISPOSAL
