Dear Mr. McArthur:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable, provided you make the labeling changes indicated below prior to release for shipment of the products bearing the amended labeling:

- 1. The retreatment statements should include a maximum frequency of application, such as, "...but not more than X times per _X_". Amend each retreatment statement on the label.
- Amend information provided under DISPOSAL to comply with PR Notice 2001-6. Include the following information: "Do Not Puncture or Incinerate. IF EMPTY: Place in trash or offer for recycling if available. IF PARTIALLY FILLED: Call your local solid waste agency or [toll free number which meets criteria in paragraph II.E] or disposal instruction".

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Preparation and Directions for Using Container:

- 1) Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. REMOVE pets and birds, cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).
- 2) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. Extinguish all flames and pilot lights. Call your gas utility or management company if you need assistance. Do not use fogger in a cabinet or under a counter or table. Use only one can in rooms 12' X 12' or smaller.
- 3) Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper or paper towels.
- 4) Break off and remove tab on side of sprayer. Tilt sprayer AWAY from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place.

- 5) Set fogger on covered stand. Immediately leave treated area.
- 6) Keep treated area closed for at least four hours. Before reoccupying area, open all doors and windows and allow treated area to air for 30 minutes.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets, or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller, instead allow fog to enter from other rooms. Turn off all ignition sources such as pilot lights (shut off gas valves), other open flames, or running electrical appliances that cycle off and on (i.e. refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights.

STORAGE & DISPOSAL

STORAGE: Store away from heat or open flames in an area inaccessible to children. DISPOSAL: Do not reuse empty container. Wrap container and put in trash.


