Notification of Packaging-Related Claims and Directions

This is to notify the Agency that we have added a delayed activation feature to our foggers, allowing consumers time to leave the area before fogging starts. As a result, we will be adding claims and brief explanatory text in the use directions to inform the consumer that the fogging is delayed, it will begin in a certain period of time, and to inform them that the release of a tiny plug of non-toxic sealant material indicates that the delayed timing period has begun. Also in the use directions, we would like to add the option of instructing the consumers to "turn off" (as an alternative to "extinguish") pilot lights etc. We believe this language is consistent with the language required by the Total Release Aerosol rule, as well as more readily understood.

Knowing that George normally likes to review changes to the use directions as amendments, I took the liberty of giving him a call and walking through these label changes with him beforehand. It was George's opinion that these claims and revisions could be filed as notifications.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 4C CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
