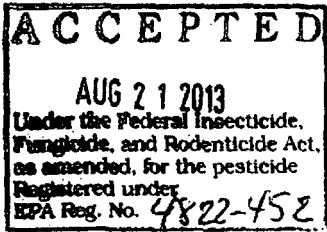





Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. 
