On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is unconditionally registered in accordance with FIFRA sec. 3(c)(5). Once a product is registered, however, it is not regarded as permanently acceptable. Registration does not eliminate the need for continual reassessment of pesticides. If the Agency determines that, at any time, additional data are required to maintain in effect an existing registration, the Agency will require submission of such data under FIFRA section 3(c)(2)(B).

1. Make the following label changes:

- a. Revise the EPA Registration Number to read EPA Reg. No.4822-458.
- b. Insert the following clarifying language at the beginning of the directions for use:
For residential use only.
- c. Revise the Environmental Hazards statement to read as follows:
The contents of this bait station are toxic to birds. Do not place bait station in water. Do not contaminate water by disposing of bait or bait station. This product is highly toxic to honey bees, which may eat the bait. Bait station should be placed in areas away from flowers to minimize attraction.
- c. Revise the Precautionary Statements to read as follows and place them on the bait station as well as the product label:
Contents of bait station are harmful if absorbed through the skin. Avoid getting contents in eyes, on skin, or on clothing. Wash hands after handling bait station and before eating drinking, chewing gum, using tobacco or using the toilet..

- d. Add a disposal statement to the bait station as follows:
Disposal: Securely wrap used bait station in several lays of newspaper and dispose of it in trash.
- 2. The acute dermal and 90-day subchronic toxicity studies using the technical were found unacceptable. However, these deficiencies will not affect the overall risk assessment characterization of this product since these studies were not used to determine endpoints. However, if new uses are submitted for registration, then these studies will need to be either upgraded or repeated.
- 3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Foraging wasps, hornets and yellowjackets can ruin your enjoyment of the outdoors. They are not only a nuisance, but their stings may be a real hazard.

Raid TVK kills wasps and hornets (and yellowjackets) that bother you when you're outside. It is the effective way to destroy yellowjacket, wasp or hornet nests (populations) even if you don't know where the nest is.

The wasps (hornets) (and yellowjackets) feed on the bait and then take the bait back to kill the bugs in the nest. There is no need to find or disturb the nest to destroy it.

Note: This product kills the following species - Yellowjackets (Wasps) and Bald-faced Hornets. Polistes Paper Wasps and Mud Daubers will not feed on this bait - do not use this product for these insects.

Each Raid TVK has a unique dual-action system. The bait contains a special liquid food that attracts the wasps (hornets) (and yellowjackets) to the bait. After 3 or 4 days, when the wasps (hornets) (and yellowjackets) are accustomed to feeding on the bait, this timed-release system begins to deliver the toxin and soon all the wasps (hornets) (and yellowjackets) will be killed and the nest, (population) destroyed.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Read ALL instructions BEFORE trying to activate the unit.

1. Only activate the unit if you plan to use it immediately. The unit CANNOT be de-activated and stored. Do not try to pull the unit apart, it will not return to its original form.
2. Turn the unit UPSIDE DOWN so that the hanging tab is on the bottom (See Figure 1). The hanging tab will fold over so that the unit will be flat on the surface. Place the unit on a solid surface, such as a table.
3. While standing, place both hands on the top of the unit. Press STRAIGHT DOWN on the unit until it collapses slightly with a crisp snapping action and sound (See Figure 2). The bait is now activated.
4. Quickly turn the unit upright with the hanging tab on the top. Keep the unit upright at all times to prevent minor leakage of the liquid bait.
5. Use the convenient (hook/wire/double-stick tape) to hang (or place) the baits where you have seen wasps (hornets) (or yellowjackets). The bait can also be placed on a flat surface. To avoid contact with wasps (hornets) (and yellowjackets) place bait out when insect activity is minimal. Wasps (hornets) (and yellowjackets) are usually found around patios, decks, fruit trees, trash containers, doors and windows. Place out of reach of children and pets. Do not place bait on a surface or in an area where people are likely to be present. Do not go near bait while wasps (hornets) (and yellowjackets) are feeding on it. For best results when hanging, keep the bait very close to the supporting structure to ensure the baits do not swing freely in the wind. Wasps (hornets) (and yellowjackets) will begin feeding on the bait soon after placement. In a few days the wasps (hornets) (and yellowjackets) will be killed and their nest population will also be destroyed.

Very severe problems may require additional baits to eliminate the problem. Continue to place new baits (bait stations) (units) out until no more wasps (hornets) (and yellowjackets) are present. Re-treat as needed.

6. The unit should be discarded after use.

STORAGE AND DISPOSAL

STORAGE: Store unused unit(s) in outer container in a cool dry area inaccessible to children.

DISPOSAL: Wrap in paper and discard in trash.
