**IF SWALLOWED:** Call a physician or Poison Control Center. Drink 1 or 2 of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

**IF ON SKIN:** Wash with plenty of soap and water. Get medical attention if irritation persists.

**DIRECTIONS FOR USE:**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**SHAKE BEFORE USE.**

Hold bottle upright and point nozzle opening in desired direction of spray. Spray the animal from a distance of 3-12 inches.

Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under body. While spraying, fluff the hair so that spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes or face.

**Repeat every week.**

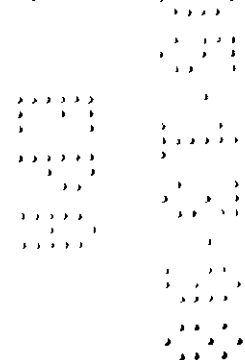
**Do not use on dogs or cats under 12 weeks.**

**Consult a veterinarian before using this product on debilitated, aged, pregnant, nursing, or medicated animals.**

**Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately**
