

Dear Ms. Rahn,

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. The statement "Pad is designed to taste bitter to help prevent ingestion." contained within the Hazards to Humans and Domestic Animals" section, is not FIFRA mandated language from the specific use pattern, nor a product classification from a FIFRA toxicity category. This language and associated graphics as shown below is considered a product attribute and not a Hazard to Humans.

#### Pad is designed to taste bitter to help prevent ingestion. (Contains Bitrex.) (Bitrex ® is a trademark of Macfarlan Smith, Ltd.)

It should be moved either to the front of the "principal display panel as a marketing claim, inserted into the directions for use near the graphics, or in the Directions for Use within a general use discussion. The statement, "**Be sure to wash hands after handling**." may remain in the Hazards to Humans and Domestic Animals section.






