Dear Mr. Mendoza:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comment below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. You must add Inhalation First Aid statements to the label as follows:

Table with 2 columns: 'If inhaled:' and a list of instructions: 'Move person to fresh air.', 'If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible.', 'Call a poison control center or doctor for further treatment advice.'

[NOTE: Your latest accepted label includes inhalation First Aid statements. If you can submit or cite data to show that the product is in category IV for inhalation toxicity, the Agency will reconsider the requirement to include these statements on the label.]

**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.  
**FOR HOUSEHOLD USE: SHAKE WELL BEFORE EACH USE.** Hold container upright. Do not spray up into air. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 12" from surface being sprayed. Spray until surfaces are wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials. More frequent application will be required to maintain control on plywood surfaces. Repeat treatment as necessary.  
**ROACHES, WATERBUGS:** Spray until wet in cracks around baseboards and other hiding places. When bugs are driven out, spray directly.  
**ANTS:** Apply to ant trails, also around doors, windows and wherever ants enter house.  
**SILVERFISH, CRICKETS, SPIDERS:** Spray areas infested by these pests.

**STORAGE AND DISPOSAL**

**STORAGE:** Store away from heat or open flames, in an area inaccessible to children.

**DISPOSAL:**

***Do Not Puncture or Incinerate!***
