- 2. Allow spray to penetrate the surface and dry, approximately 20 minutes. For best results vacuum thoroughly.

For best results repeat treatment at least every 4 weeks.

#### TO ELIMINATE MOLD AND MILDEW ODORS:

Clean surface prior to application. Spray surface until covered with mist. Allow to stand 10 minutes to air dry. Repeat as necessary.

## TO DEODORIZE:

Spray surface until covered with mist. Allow to stand 10 minutes to air dry. Repeat as necessary.
