- 3. The submitted residual self-sanitizing test data are not acceptable for the following reasons:
- (a) Test and control surfaces were not recontaminated with the test inocula with organic soil at 24 hour intervals for up to seven days. See itme 9.2.5 of the protocol under the heading "Procedures".
- (b) On day zero and once per day for up to seven days, tiles were rinsed for 5 minutes only instead of 30±5 minutes. See item 9.2.1 fo the protocol under the heading "Procedures".
- (c) The 24 hour contact time employed in the test is too long and it does not simulate the real use situation.
- 4. Delete all virucidal claims from the label. The data submitted to support these claims are not acceptable at this time.
- 5. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
