- d. On page 2, revise item # 3 to read: "Reduces 99.9% of some germs such as Salmonella choleraesuis, Enterococcus faecalis and Escherichia coli (E. Coli ATTC 11229) in the toilet bowl water".

Delete the wording Streptococcus and Strep, these wordings are not acceptable. The unacceptable wordings indicated in #3 are applicable below for items # 4.

- e. On page 2, revise item #4 to read: Vanish* Drop-Ins* fights tough stains and reduces 99.9% of many germs (such as Salmonella choleraesuis, Enterococcus faecalis and Escherihia coli (E. Coli ATCC 11229) in the toilet bowl water for up to 9 weeks.
- f. On page 2, revise item #5, "Vanish Drop-Ins with stain Repel fights tough stains and kills odor-causing germs for up to 9 weeks" to read: "Vanish Drop-Ins with stain Repel fights tough stains and reduces odor-causing germs for up to 9 weeks".
- g. On page 2, revise item #6 to read: "Vanish Drop-Ins fights tough stains and reduces germs up to 9 weeks".
- h. On page 2, item # 26, delete the wording harmless. This is considered an implied safety claim.
- I. On page 2, item # 30, revise "Cleans up to 4 months" to read: "Cleans up to 9 weeks".
- j. On page 2, item # 31, revise to read: "Deodorizes for up to 9 weeks".
- k. On page 2, item # 36, revise to read: "Controls odor produced by odor-causing bacteria".
- l. On page 2, item # 37, revise to read: "Controls the growth of bacteria that cause odors".
- m. On page 2, item # 38, revise to read: "Controls odors caused by odor causing germs".
- n. On page 2, item # 49, delete the word "Safe".

- o. On page 3, item # 51, delete the entire phrase "Bowl water not harmful to children or pets. However, it is not recommended that pets drink regularly from the toilet. Label claims, wordings and terms which implicate the safety of a product are not acceptable and must be removed from the label.
- p. On page 3, item # 54, the phrase "New, Improved" may be used only for 6 months.

3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
