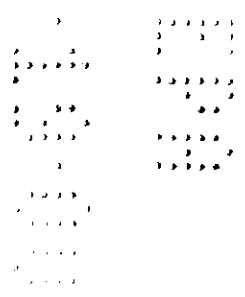

Directions for Use:

This statement will only be used if a thermal seal is used on top of the container:
Unscrew cap, remove liner and replace cap tightly before use.

1. Sprinkle evenly onto carpet about ¼ cup (or) (70g) (2.5 oz.) per square yard. One (canister) (pouch) will cover (6' X 10' area for the 16 oz. size or 10' X 14' for the 28 oz. size or 10' X 12' for the 30 oz. size).
2. Allow powder to penetrate into (remain on) the carpet for 30 minutes.
3. Vacuum thoroughly.

For best results on medium to heavy pile carpets, first brush the powder into the carpet with a broom using light strokes, leave for 30 minutes, then vacuum.

Keep children and pets off treated areas during application and until area is vacuumed.

For best results, repeat treatment at least every 2 to 4 weeks.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS
