The revised basic CSF and two alternate confidential statement of formulas (CSF) dated 3 November 2004, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, are acceptable. These CSFs have been added to the registration file for the aforementioned product. Previous CSFs are now considered superseded.

The label modifications submitted in response to PRNs 2001-1 and 2001-6, are acceptable.

The following marketing claims are not supported by product performance data and must be removed from the label:

- (Repels)(Shields against)(Protects against) mosquitoes that may carry (West Nile Virus)(Yellow Fever)(Encephalitis)
- Long lasting protection from mosquitoes, black flies, sand flies, stable flies, gnats, no-see-ums and fleas [This statement is misleading; 3-4 hours is not long lasting protection in comparison to other repellents.]
- Gives effective protection against mosquitoes, black flies, sand flies, stable flies, gnats, no-see-ums and fleas [Remove black flies, sand flies, stable flies, gnats, and no-see-ums.]
- Won't stain [Qualify that it should be tested on an inconspicuous area of the clothing prior to application]
- No fragrance [For use only with formulation SOF36053A]
- Fragrance free [For use only with formulation SOF36053A]

The label amendment submitted meets the standards set forth in PR Notice 2001-1 and is accepted conditionally.
