The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The alternate brand names "OFF! Deep Woods Insect Repellent XI; OFF! Deep Woods Sportsmen Insect Repellent IX" have been added to the product record.
