On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is **conditionally** registered in accordance with FIFRA sec. 3(c)(7)(A), provided that:

1. You will submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
2. You will make the following label changes before you release the product for shipment:
 - a) Revise the EPA Registration Number to read "EPA Reg. No. 4822-562."
 - b) Delete "(10*) (12*) weeks" from the "Lasts.../Kills..." claims and throughout the label. The 10/12 weeks residual kill claims do not apply to all pests on the label. A claim of 10/12 weeks residual control must clearly state that it applies to German cockroaches on non-porous surfaces only. The proposed footnote (10*...) would best serve the purpose of listing examples of non-porous surfaces. Please see attached Efficacy Review Memorandum for further details.
 - c) Remove or qualify repellency claims. Claims only apply to German cockroaches.
 - d) Revise "For household use only" to read "For residential use."
 - e) Please note that "New formula!" is a time limited claim. This marketing claim may be used for a period of 6 months following release of the product.
 - f) Move the statements "Do not apply to humans, pets...and food handling equipment" from the Precautionary Statements to the Directions for Use section of the label.

- g) Immediately below the First Aid Statements and clearly distinguished from it, add: *"Have the product container with you when calling a poison control center or doctor or going for treatment."* Please refer to the boxed format example provided with PR Notice 2001-1.
- h) The container disposal statements for pesticides have been revised. Refer to PR Notice 2007-4 and modify your label accordingly.

- 3. The product chemistry data requirements for the 830 Series Subgroups A and B guidelines are satisfied with the exception of the one year storage stability (830.6317) and corrosion characteristics data (830.6320). These outstanding data must be submitted to the Agency.
- 4. The acute toxicity profile of the product has been determined to be as follows:
 - Acute Oral ----- IV Primary Eye Irritation ----- III
 - Acute Dermal --- IV Primary Dermal Irritation --- IV
 - Acute Inhalation --- IV Skin Sensitization ----- Negative
- 5. The confidential statements of formula (CSF) for the basic and two alternate formulations, all dated 07/23/08 are acceptable.
- 6. Please submit three (3) copies of your revised labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR HOUSEHOLD USE: SHAKE WELL BEFORE EACH USE. Hold container upright. Do not spray up into air. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 12" from surface being sprayed. Spray until surfaces are wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials. To maintain control on plywood surfaces, retreat every 7 weeks. On all other surfaces, retreat every 12 weeks.

ROACHES, WATERBUGS: Spray until wet in cracks around baseboards and other hiding places. When bugs are driven out, spray directly.

ANTS: Apply to ant trails, also around doors, windows and wherever ants enter house.

SILVERFISH, CRICKETS, EARWIGS, SPIDERS: Spray areas infested by these pests.

BLACK WIDOW SPIDERS, SCORPIONS: Must be sprayed directly (to be killed).

FOR OUTDOOR USE: Hold container upright. Do not spray up into air. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 12" from surface being sprayed. For best results, spray when air is calm. Spray with wind if breeze is blowing. Do not spray up into air or directly overhead. Do not apply directly to water.

To control building infestations of ants, cockroaches, waterbugs, palmetto bugs, crickets, spiders, silverfish, millipedes, centipedes and earwigs: Apply to outside surfaces of buildings where insects tend to enter. Spray screens, window frames, eaves, porches, patios, garages and garbage areas to prevent entry into homes.
