Dear Daniel Usry:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The alternate brand name, ***“Raid Max Defend Spider and Scorpion Killer”*** has been added to the product record.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Imiprothrin and Deltamethrin Interim Decisions, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 12 months, you may only distribute or sell this product if it


bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

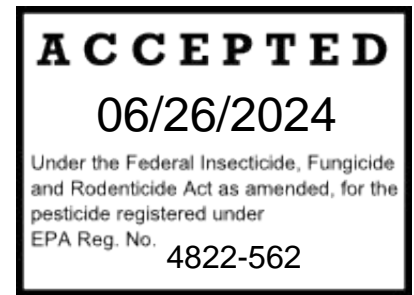

FOR HOUSEHOLD USE: SHAKE WELL BEFORE EACH USE. Hold container upright. DO NOT spray up into air. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 12" from surface being sprayed. Spray until surfaces are wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials. To maintain control on porous surfaces, retreat every 7 weeks. On non-porous surfaces, retreat every 12 weeks.

ROACHES: Spray until wet in cracks around baseboards. When bugs are driven out, spray directly.

ANTS: Apply to ant trails, around doors, windows and wherever ants enter house.

SILVERFISH, CRICKETS, EARWIGS, SPIDERS: Spray areas infested by these pests.

BLACK WIDOW SPIDERS, SCORPIONS: Must be sprayed directly to be killed.

FOR OUTDOOR USE: Cover all food handling surfaces or wash thoroughly after treatment and before use. Hold container upright. DO NOT spray up into air. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 12" from surface being sprayed. For best results, spray when air is calm. Spray with wind if breeze is blowing. DO NOT spray up into air or directly overhead. DO NOT apply directly to water.

To control building infestations of ants, cockroaches, waterbugs, palmetto bugs, crickets, spiders, silverfish, millipedes, centipedes and earwigs: Apply to outside surfaces of buildings where insects tend to enter. Spray screens, window frames, eaves, porches, patios, garages and garbage areas to prevent entry into homes.

All outdoor applications, if permitted elsewhere on this label, must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

- Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure;
- Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
- Application to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g. driveways, sidewalks, etc.) up to 2 feet above ground level;
- Application to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

Spot treatments must not exceed two square feet in size (2ft. by 1 ft.).

DO NOT apply or irrigate to the point of runoff.

DO NOT make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

Treat surfaces to ensure thorough coverage but avoid runoff.

To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

- De-clutter outdoor areas to remove hiding places close to the home(debris, stones, piled wood, loose bark, or mulch)

STORAGE AND DISPOSAL

STORAGE: Store away from heat or open flames, in an area inaccessible to children. Store in a cool dry place.

DISPOSAL: DO NOT Puncture or Incinerate! Non-refillable container. DO NOT reuse or refill this container. DO NOT pour or dispose down-the-drain or sewer.
