## DIRECTIONSFOR USE It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Apply this product only as specified on the label. Do not contaminate food or feedstuffs. SHAKE WELL BEFORE USING. Do not allow adults, children, or pets to enter the treated area until spray has dried or until vapors and mists have dispersed, and the area has been thoroughly ventilated. Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Do not remain in treated area. Exit area immediately and remain outside the treated area until vapors or mists have dispersed. Remove pets, birds, and cover fish aquariums before spraying. Do not wet plants to point of runoff or drip. Do not wet articles to point of runoff or drip. Do not use treated article until spray has dried.
