Dear Daniel Usry:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The alternate brand names, "**Raid MAX Flying Insect Killer 7**" and "**Raid MAX Defend Flying Insect Killer 7**" have been added to the product record.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the d-Phenothrin and Prallethrin Interim Decision, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it


bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

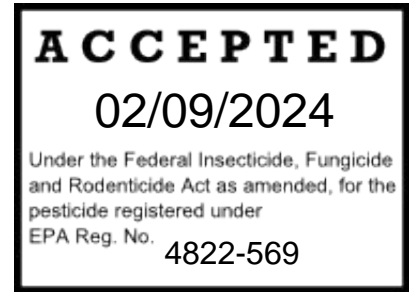

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

### FOR USE IN RESIDENTIAL AREAS ONLY

Shake before using. Point spray nozzle away from face and press button, holding container as upright as possible.

RESTRICTIONS: Do not enter or allow others to enter the treated area until the sprays have dried. Do not allow people or pets to enter treated area until vapors, mists and aerosols have dispersed, and the treated area has been thoroughly ventilated. Wait two (2) hours after application, then open windows, vents and doors for two (2) hours. If an odor is still detected, additional ventilation is required. Remove pets, birds and cover fish aquariums and ornamental fish ponds before spraying, and turn aquarium systems off. In the home, cover all food processing surfaces and utensils during treatment or thoroughly wash utensils before use. Cover exposed food and remove utensils in serving areas. Application is prohibited directly to sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. Do not allow to enter indoor or outdoor drains. No permita la entrada a desagües internos o externos. All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the

following permitted uses: 1. Application to pervious surfaces such as soil, lawn, turf, and other vegetation; 2. Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure; 3. Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch; 4. Applications to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

Spot treatments must not exceed two square feet in size (2ft. by 1 ft. or 4 ft. by 0.5 ft.).

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.”

Do not spray the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application. Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment. Do not apply or irrigate to the point of runoff.

Do not make applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application. Treat surfaces to ensure thorough coverage but avoid runoff. To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

#### **TO KILL FLYING INSECTS:**

##### **INDOORS:**

##### **FLIES, MOSQUITOES, SMALL FLYING MOTHS, NON-BITING (FUNGUS) GNATS, FRUITFLIES:**

[1] (With RAID H6A) there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. Spray (RAID) [brand name] up into the air with a sweeping motion, keeping about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics and furniture, until the room is thoroughly misted. Do not remain in treated area. Keep room closed for two (2) hours. Ventilate room thoroughly before re-entry.

[2] (With RAID (H6A) (brand name)) there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. For the average size room (1000 cubic feet) (30 cubic meters) spray in a slow sweeping motion for 8 to 10 seconds starting from the middle of the room and backing toward the door, directing the spray to all areas of the room. Keep spray about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics and furniture. Do not remain in treated area. Keep room closed for two (2) hours. Ventilate room thoroughly before re-entry.

For fast knockdown, spray directly at insects, keeping about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics, and furniture.

**FOR RESIDUAL CONTROL OF MOSQUITOES DURING THE NIGHT:** Treat the room at the rate of 8-10 seconds of spray per (1000 cubic feet) (30 cubic meters). Close doors and windows, spray in a slight upward direction covering all areas of the room, staying about 3 feet (36" (inches)) (1 meter) from walls, fabrics and furniture. After spraying, close the door as you leave the room. Keep doors and windows closed for about two (2) hours before re-entering. Doors and windows may then be reopened.

In kitchens, treat areas that may attract these insects: around windows, sinks and garbage cans. Cover or remove exposed food, utensils and food handling equipment.

For residual control of insects, spray screens and around doors and windows where insects enter the house from a distance of about 18" (inches) (1/2 meter). Also, spray screens and doorways on patios. Check for potential staining and damage in an inconspicuous place before complete treatment.

**WASPS, HORNETS, YELLOW JACKETS and ASIAN LADY BEETLES:** Spray directly at stray insects that enter building.

**OUTDOORS:**

**FLIES, MOSQUITOES, SMALL FLYING MOTHS, ASIAN LADY BEETLES, NON-BITING (FUNGUS) GNATS, FRUITFLIES, BOXELDER BUGS:** To reduce annoyance of these insects, spray area when air is calm for best results. If a slight breeze is blowing, spray with the wind, allowing the spray to drift over the area to be treated staying at least 3 feet (36" (inches)) (1 meter) from plants and bushes. Allow a couple of minutes for product to take effect. Give special attention to breeding areas such as garbage cans and compost piles. Treat these areas from a distance of about 18" (inches) (1/2 meter) when possible. When spraying in garages be careful that spray does not contact painted surfaces of vehicles.

**TO KILL CRAWLING INSECTS:**

**INDOORS:**

**FLEAS:** Spray floors, floor coverings and sleeping quarters of pets. Do not treat animals with this product.

**ROACHES, WATERBUGS, SILVERFISH, FIREBRATS, CRICKETS:** Spray hiding places: baseboards and floor boards, moist places, cabinets and other storage areas, behind bookcases, and openings around sinks, drains and pipes, hitting as many insects as possible from a distance of about 18" (inches) (1/2 meter). In kitchens, also spray around refrigerators, stoves and storage areas. When spraying by stoves or water heaters, make sure pilot light is first turned off.

**ANTS:** Spray trails, hills, around doors, openings around pipes, window frames, and baseboards where ants crawl, hitting as many as possible from a distance of about 18" (inches) (1/2 meter). In kitchens, also spray around refrigerators, stoves and storage areas. When spraying by stoves, make sure pilot light is first turned off.

**SPIDERS, SOWBUGS, PILLBUGS:** Spray webs and places where these pests crawl from a distance of about 18" (inches) (1/2 meter). These insects tend to hide in dark moist areas. Hit as many as possible.

**CARPET BEETLES:** Hit these bugs directly with spray on sections of floor, baseboards, shelves and underside of carpets from a distance of about 18" (inches) (1/2 meter).

**BEDBUGS:** DO NOT APPLY THIS PRODUCT TO MATTRESSES OR BEDDING. Disassemble bed frame and treat all surfaces. Allow to dry completely before reassembling bed. Treat around beds, on and under rugs near bed, and cracks and crevices along baseboards near bed.

## **OUTDOORS:**

**FLEAS:** Spray kennels, doghouses and places where animals rest, including porches and mats by doors. Do not treat animals with this product. Allow treated surfaces to dry before letting pets reoccupy these areas.

**CRICKETS, SOWBUGS, PILLBUGS:** Spray around doors, foundations and damp moist places where these insects hide, hitting as many as possible from a distance of about 18" (inches) (1/2 meter).

**ANTS:** Spray trails, hills, around doors, openings around pipes, and window frames where ants enter and crawl, hitting as many as possible from a distance of about 18" (inches) (1/2 meter).

**SPIDERS:** Spray webs and places where these pests crawl. Hit as many as possible.

**GARDEN BUGS:** Product is for use on ornamental garden plants only. It is not for use on edible crops. To kill Aphids, Army Worms, Boxelder Bugs, Caterpillars, Climbing Cutworms, Fruit Flies, Japanese Beetles, Leafhoppers, Phorid Flies, Potato Beetles, Thrips, Webworms and Whiteflies on ornamental garden plants: Salvias, Roses, Gladiolas, Azaleas, Dahlias, Chrysanthemums, Asters, Marigolds, Delphiniums, Petunias, Begonias, Shrubs, Butterfly Plants, Dieffenbachia, Dracaenas, Ferns, Ficus, Palms, Pepperonia, Philodendrons, Piggyback Plants, Pines, Pothos, Spider Plants, Succulents, Evergreens, Fushia, Geraniums, Irises, Wandering Jews, Zinnias, Peonies, Impatiens, Alyssum, African Violets and English Ivy. Spray when air is still and temperature is not above 90°F (32°C). Spray with slow sweeping motion 3 feet (36" (inches)) (1 meter) from all plants. Avoid wetting - a light spray kills pests effectively. Spray in short bursts. Repeat application from time to time as long as insects are present. Use with care on tender foliage, young plants and new growth.

## **STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Store in a cool, dry place away from heat or open flame.

**DISPOSAL:** Do Not Puncture or Incinerate! If empty: This container may be recycled in the few but growing number of communities where (steel) aerosol can recycling is available. ##### **INDOORS:**

##### **FLIES, MOSQUITOES, SMALL FLYING MOTHS, NON-BITING (FUNGUS) GNATS, FRUITFLIES:**

[1] (With RAID H6A) there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. Spray RAID up into the air with a sweeping motion, keeping about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics and furniture, until the room is thoroughly misted.
