2. You make the following label changes before releasing the product for shipment:
 - a) Revise the EPA Registration Number to read "EPA Reg. No. 4822-573".
 - b) The directions for use must better describe the application pattern to ensure results consistent with the submitted data. Directions should include the fogger application to the air together with treatment of surfaces in the area – vegetation, articles, etc. instead of just chairs/compost/garbage cans.

On page 2 modify the fifth bullet in the directions for use to read: "Spray articles and vegetation in the area including plant leaves and foliage, furniture (except seating and table top surfaces), tents, outdoor screening, deck railings, campers, and other surfaces that pests may contact or rest upon."

Add at the beginning of the directions of use: "Do not apply directly to food, or to food serving or food preparation surfaces. Do not apply to pets or to your skin or clothing. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray indoors."

3. Marketing Claims.

- a. The product application is not a barrier. Remove:
 (bug barrier lasts)
 Protection barrier
 Perimeter of protection
 (The) Backyard (perimeter) (campsite) (bug) barrier
- b. Remove: "hornets" from the label because data on hornets was not submitted or cited.
- c. Remove the following repellency and fast kill claims: Instant repellency (kill)
- d. Remove the term "Controls" from the label because this is a short-lived product.
- e. Remove "long-lasting" from the label and refer to the duration of activity – up to 6 hours.
- f. The reapplication interval is six hours. Remove "Repeat as needed."
- g. Remove protection claims as the product does not provide complete protection:
 (protects against) (protects) (protection) (shields against)
- h. Remove: (no water) required (needed) (necessary) because this statement is not relevant to the use of a 16 oz. aerosol yard fogger.

4. The basic Confidential Statement of Formula (CSF) dated October 27, 2009 is acceptable and is the basic CSF of record. The Alternate CSF dated October 27, 2009 is also acceptable.



SHAKE BEFORE USING

For flying insects: Flies, mosquitoes, non-biting gnats, small flying moths, wasps, hornets and multi-colored asian lady beetles

Hold can on slight downward angle. • Point nozzle away from face, other people and animals. • Spray toward area being treated. • Allow spray to drift over area and settle. • Spray articles in the area like foliage and furniture legs from 4 to 6 feet away. • For best results, spray when air is calm. IF BREEZY, spray with the wind. IF NOT BREEZY, spray out from center of area being treated. • Give special attention to breeding areas such as garbage cans and compost piles. • Repeat as necessary. [• DO NOT SPRAY DIRECTLY ON SKIN.]
