TO KILL FLYING INSECTS:

INDOORS:

FLIES, MOSQUITOES, SMALL FLYING MOTHS, NON-BITING (FUNGUS) GNATS, FRUITFLIES:

[1] (With H7A-US) there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. Spray RAID up into the air with a sweeping motion, keeping about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics and furniture, until the room is thoroughly misted. Do not remain in treated area. Keep treated room closed for at least 15 minutes following application. Thoroughly ventilate room before re-entry.

[2] (With H7A-US) there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. For the average size room (10ft x 12ft x 8ft) (1000 cubic feet) (30 cubic meters) spray in a slow sweeping motion for 8 to 10 seconds starting from the middle of the room and backing toward the door, directing the spray to all areas of the room. Keep spray about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics and furniture. Do not remain in treated area. Keep treated room closed for at least 15 minutes following application. Thoroughly ventilate room before re-entry.

[either [1] or [2] will be on the product label, not both]

For fast knockdown, spray directly at insects, keeping about 3 feet (36" (inches)) (1 meter) from interior walls, fabrics, and furniture.

In kitchens, be sure to treat areas that may attract these insects such as around windows, sinks and garbage cans.

Spray directly on stray WASPS, HORNETS, YELLOW JACKETS and ASIAN LADY BEETLES that enter building.

For residual control of listed insects, spray screens and around doors and windows where insects enter the house from a distance of about 18" (inches) (½ meter). Also, spray screens and doorways on patios. It is recommended to check for potential staining and damage in an inconspicuous place before complete treatment.

For residual control of mosquitoes during the night: treat the room at the rate of 8 seconds of spray per 1000 cubic feet (30 cubic meters). Close doors and windows, spray in a slight upward direction covering all areas of the room, staying about 3 feet (36" (inches)) (1 meter) from walls, fabrics and furniture. After spraying close the door as you leave the room. Keep doors and windows closed for at least 15 minutes following application. Thoroughly ventilate room before re-entry. Doors and windows may then be reopened.

OUTDOORS:

FLIES, MOSQUITOES, SMALL FLYING MOTHS, ASIAN LADY BEETLES, NON-BITING (FUNGUS) GNATS, FRUITFLIES, BOXELDER BUGS:

To reduce annoyance of these insects, spray target area when air is calm for best results. If a slight breeze is blowing, spray with the wind, allowing the spray to drift over the target area staying at least 3 feet (36" (inches)) (1 meter) from plants and bushes. Allow a couple of minutes for product to take effect. Give special attention to breeding areas such as garbage cans and compost piles. Treat these areas from a distance of about 18" (inches) (½ meter) when possible. When spraying in garages be careful that spray does not contact painted surfaces of vehicles.

TO KILL CRAWLING INSECTS:

INDOORS:

FLEAS: Spray floor coverings and sleeping quarters of pets. This product is <u>not</u> intended for direct application to domestic (companion) animals.

ROACHES, WATERBUGS, SILVERFISH, FIREBRATS, CRICKETS: Spray hiding places such as baseboards and floor boards, moist places, cabinets and other storage areas, behind bookcases, and openings around sinks, drains and pipes, hitting as many insects as possible from a distance of about 18" (inches) (½ meter). In kitchens, also spray

around refrigerators, stoves and storage areas. When spraying by stoves or water heaters, make sure pilot light is first turned off.

ANTS (except fire, harvester, and pharaoh ants): Spray trails, hills, around doors, openings around pipes, window frames, and baseboards where ants crawl, hitting as many as possible from a distance of about 18" (inches) (½ meter). In kitchens, also spray around refrigerators, stoves and storage areas. When spraying by stoves, make sure pilot light is first turned off.

SPIDERS (except black widow and brown recluse spiders), MILLIPEDES, SOWBUGS, PILLBUGS: Spray webs and places where these pests crawl from a distance of about 18" (inches) (½ meter). These insects tend to hide in dark moist areas. Hit as many as possible.

CARPET BEETLES: Hit these bugs directly with spray on sections of floor, baseboards, shelves and underside of carpets from a distance of about 18" (inches) (½ meter).

BEDBUGS: DO NOT APPLY THIS PRODUCT TO MATTRESSES OR BEDDING. Disassemble bed frame and treat all surfaces. Allow to dry completely before reassembling bed. Treat around beds, on and under rugs near bed, and cracks and crevices along baseboards near bed.

OUTDOORS:

FLEAS: Spray kennels, doghouses and places where animals rest, including porches and mats by doors. This product is <u>not</u> intended for direct application to domestic (companion) animals.

CRICKETS, MILLIPEDES, SOWBUGS, PILLBUGS: Spray around doors, foundations and damp moist places where these insects hide, hitting as many as possible from a distance of about 18" (inches) (½ meter).

ANTS (except fire, harvester, and pharaoh ants): Spray trails, hills, around doors, openings around pipes, and window frames where ants enter and crawl, hitting as many as possible from a distance of about 18" (inches) (½ meter).

SPIDERS (except black widow and brown recluse spiders): Spray webs and places where these pests crawl. Hit as many as possible.

STORAGE AND DISPOSAL:

PESTICIDE STORAGE: Store in a cool, dry place away from heat or open flame.

CONTAINER DISPOSAL:

Do Not Puncture or Incinerate!
