Contains Pyrethrins a botanical insecticide derived from Chrysanthemum flowers and Cyfluthrin a synthetic insecticide

This notification is consistent with Section II N of PR Notice 98 10 since it is consistent with 40 CFR part 156 and involves no change in the ingredients statement signal word use classification precautionary statements statements of practical treatment (First Aid) physical/chemical/biological properties storage and disposal or directions for use In addition this marketing claim is consistent with marketing claims recently approved by RD and is not false or misleading since it calls out both Pyrethrins and Cyfluthrin with equal prominence
