DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner that is inconsistent with its labeling.

Remove refill can, battery, plastic shroud (holder) and dispenser from packaging. (Install batteries into dispenser.) (Connect battery to terminal and insert into the battery compartment.) Shake refill can well and then remove protective over-cap from can. Make sure dispenser is in the "off" position. (Insert refill into dispenser.) (Push down and twist the dispenser slightly until it stops and locks onto the can.) (Insert assembled into decorative housing.) (Lower the refill into the holder and press firmly to attach.) Place the dispenser in an outdoor area away from food and food preparation areas.

To activate, (press the button 1hr, 2hrs or 3hrs for the hours of protection you need.) (press the button to advance to desired hourly setting.) (press the button to activate.) (move the switch to "on" position.) Avoid pointing dispenser at face. The dispenser will activate 10 seconds after the button is selected. (Lights will flash.) The dispenser automatically shuts off (at the end of the selected time.) (after 3 hours.) To turn the dispenser off manually, simply press the OFF button. (Advance) (Move) (switch to "off" position.)

When product has been exhausted (is empty), remove the aerosol can and replace with a SGOL refill. To remove the refill can, turn in counter clockwise direction. (When battery light flashes (red), change batteries.) The dispenser will automatically release a mosquito repellent mist into the air.

Use only one unit per 12 ft by 12 ft area (225 sq ft.)

Attention: Periodically sprays automatically. Stay out of contact with mist (spray). Keep out of reach of children and pets. Follow all precautions and use instructions (on) (can) (outer package) (refill).

[Note to reviewer: The efficacy testing method supporting this product uses a 8.5 foot radius circle of testing. This is equivalent to 225 sq. ft. We also want the option of claiming an area in the shape of square, a concept more easily understood by the consumer. While a 15x15 ft square is equivalent in square footage to the 17 ft diameter circle, the 15 ft square does not fit inside the circle, whereas a 12 X 12 ft square does. Therefore, we make both a 12 x 12 ft square and a 225 sq. ft. claim. Please note that we will only use one of these options on label and will not mix these claims since, while both true, they are not equivalent.]
