b. Under Hazards to Humans and Domestic Animals add as the last sentence "Wear long-sleeved shirt and long pants, socks, shoes and gloves".

c. Add at the end of the First Aid statements "Have the product container or label with you when calling a poison control center or doctor, or going for treatment. You may also contact 1-800-xxx-xxxx for emergency medical advice."

d. Since the cited acute oral toxicity study is a category IV you may delete the "If Swallowed" statement.

e. Delete "Forest Fresh Scent", "Spring Fresh Scent", "Floral Scent", "Fresh Scent", "Clean Fresh Scent", "House and Yard Line", "Garden Center Size", "Value Size", "Low Chemical Odor", "Low Chemical Smell", "Low Odor", "(Leaves) No Lingering Chemical Odor", "(Leaves) No Lingering Odor", "(Leaves) No Lasting Odor", and "(Leaves) No Lasting Chemical Odor".

f. On page 3 change "To maintain control of indoor surfaces, retreat every (4)(5)(6) weeks. Repeat treatment as necessary." to read "To maintain control of indoor surfaces, retreat every (4)(5)(6) weeks as necessary."

2. You must generate a one year storage stability and corrosion characteristics study corresponding to guideline 830.6317 and 830.6320 on the proposed product. It is required that the observations be made at 0, 3, 6, 9, and 12 month intervals. The results must be submitted to the Agency in electronic and hard copy format. The reduction of the end-use product must be evaluated and submitted to the Agency.

Please note that if the treated poultry litter is to be land applied (e.g. agronomic, horticultural, compost, or other purposes), this product should include language that stipulates that the product should be used in accordance with a comprehensive nutrient plan (CNMP).

You must submit and/or cite all data required for registration of your product under FIFRA Section 3(c)(5) when the Agency requires all registrants of similar products to submit such data, and submit acceptable responses required for registration review of your product under FIFRA.



[Product Name] kills bugs fast – (on)(by) contact.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR HOUSEHOLD USE: SHAKE WELL BEFORE EACH USE. Hold container upright. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 18" from surface being sprayed. Spray until surfaces are wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials.
