The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Deltamethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

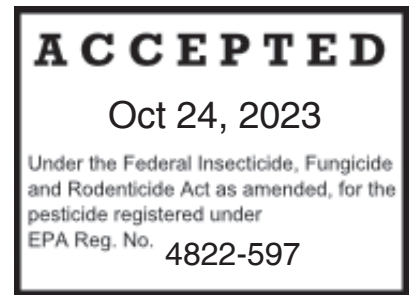

General Information:

Do not allow product to come into contact with children or pets until dry. Do not apply to surfaces that come in (direct) contact with food. Cover or remove all food and cooking utensils or wash thoroughly after treatment. Remove pets and birds and cover aquariums. Do not use in commercial food handling establishments, restaurants, or other places where food is commercially prepared, processed, served or stored. Do not use on dogs or cats. (Wash hands after use.)

To Use:

Remove cap. Shake well and test in an inconspicuous area before applying. Apply to clean, dry surfaces.

- (1.) First use: press sponge firmly against flat surface to break seal. Press again to saturate sponge.
- (2.) Glide applicator in a continuous motion to create a band of bug defense.
- (3.) As needed, press tip in a downward motion to keep sponge saturated for full coverage and no gaps.

Product dries quickly.

(Reapply after cleaning (or washing) a treated surface, but do not apply more than once a week.) (Replace cap when done.) (Wash hands after use.)

Ants, Cockroaches (Including Adult and Immature Stages Of Both Non-Resistant And Organophosphate And Carbamate Resistant Strains), Boxelder Bugs, Crickets, Dermestids, Firebrats, Ground Beetles, Palmetto Bugs, Pillbugs, Silverfish, Sowbugs and Waterbugs: Apply as a spot and crack and crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. Repeat as necessary but not more than once per week.

Ticks [(Including Deer Ticks Which May Carry Lyme Disease)] and Fleas on Surfaces: Remove pet bedding and destroy or clean thoroughly. Apply to pet resting quarters. Put fresh bedding down once area has dried. Do not apply to animals directly. For best results, pets should be treated with an appropriate flea and/or tick control product registered for use on pets before allowing them to return to the treated area. Do not allow pets to contact treated surfaces until dry. Treat rugs and carpets where infestations are bad. Delicate fabrics should be tested for staining in an inconspicuous area prior to use.

Flying Insects- Houseflies, Gnats, Mosquitoes and Small Flying Moths: Apply to localized resting areas, such as inside surfaces of window and door frames, surfaces around light fixtures and cords, railings, etc. and anywhere these insects may rest. Insects coming to rest on treated surfaces will be killed.

Pantry Pests - Grain Beetles (Rusty, Merchant and Saw-Toothed), Flour Beetles (Red and Confused), Chocolate Moths, Cigarette Beetles, Clover Mites, Cluster Flies, Drugstore Beetles, Elmleaf Beetles, Rice Weevils, Lesser Grain Borers, Spider Beetles and Tobacco Moths: Treat bugs you see, away from infested food. Remove all food-stuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply to shelves and in cracks and crevices behind and under cupboards and cabinets. Allow to dry prior to replacement of shelf paper, food and utensils. Wash any exposed food handling surfaces and utensils before use.

Bedbugs and Lice: Wash linens, blankets and bed covers in hot water and dry using the high heat setting before reuse. Apply to mattress tufts, folds and edges. Apply to the interior of the frame. Allow to dry before contacting or remaking bed.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area inaccessible to children and pets and away from heat, sparks and open flame. Protect from freezing. If freezing occurs, allow product to thaw and shake well before using. Some product separation may occur on freezing which is reversible on shaking. Freezing does not adversely affect the performance of this product.

DISPOSAL: Non-refillable container. Do not reuse or refill this container. If empty: Place in trash or offer for recycling if available. If partially filled: Do not pour or dispose down-the-drain or sewer. Call your local solid waste agency or 1-800-529-3394 for disposal instructions. Bud bugs:

The key to solving a bed bug problem is early detection. Be watchful for signs of an infestation like skin bites or small spots of blood on sheets or pillow cases.

After mattress treatment, purchase a high quality mattress encasement so that mattress does not need to be retreated.

Before treatment, wash linens, bed covers and curtains using hot water; dry items using high heat setting.

Store treated or uninfested items in sealed plastic bags to avoid a future infestation.

Clean and vacuum well before treatment, to remove as many bugs as possible.

Stay vigilant: repeat applications may be needed over the next two months.

Fleas and Ticks:

At the time of room and/or pet treatment, wash all pet bedding to remove existing fleas and eggs.

Shampoo pets regularly with a flea shampoo.
