Shake well. (Turn)(Move)(Set) the (Reusable) (Auto) Trigger to the (on) (unlock(ed)) ([icon]) (position). Return to (off) (lock(ed))([icon]) position after use. Hold container upright and spray away from face, (one to two)(two to three)(one to four)(two to three)(two to four)(three to four) feet from the surface (being treated). Squeeze trigger and spray until surface is moist but not dripping. Over application may cause damage. Repeat spraying as necessary, but no more than once per week. (Keep the Reusable Auto Trigger for use on compatible refills.)

[Alternate assembly instructions for use on products that require assembly of sprayer:]

Shake well. (Remove cap and trigger (holster) ((hanger)). (Remove cap and bag containing trigger and hose.) INDOORS:

To Kill: Asian Lady beetles, Boxelder Bugs, Brown Marmorated Stink Bugs (BMSB), Clover Mites, Cockroaches, Crickets, Earwigs, Firebrats, Millipedes, Palmetto Bugs, Psocids, Sewbugs, Silverfish, Stink Bugs, Spiders and Water Bugs. Spray area where these bugs are found or normally occur including dark corners of rooms and closets, window sills and frames, cracks and crevices in walls, along and behind baseboards, beneath and behind sinks, stoves, refrigerators, and cabinets, and around plumbing and other utility installations.

To Kill: Ants: Apply to ant trails, around doors and windows, and wherever else ants may find entrance.

To Kill Carpet Beetles: Thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets, on shelving, and wherever else insects are seen or suspected. Note: Check carpet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpeting.

To Kill Fleas and Brown Dog Ticks: Thoroughly spray pet beds and resting quarters and nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floors and floor coverings where fleas and ticks may be present. Pet bedding should be replaced with clean fresh bedding after treating the area. Do not treat pets with this product. To control the source of flea infestations, treat pets with a product registered for application to animals.

To Kill Bedbugs: Thoroughly inspect area of suspected bed bug infestation and note potential harborage sites or actual infestations. Remove and/or pick up clothing and other obstacles that may prevent thorough inspection or treatment. Remove and sanitize infested bedding (pillows and linens), clothing, or other items. Apply on mattresses as a spot treatment to mattress seams, edges, buttons, and tufts of bed only. Do not use directly on pillows, bed linens, or clothes. Do not saturate the mattress and do not treat entire surface area of mattress. Allow mattress to dry thoroughly before replacing pillow and/or bed linens.

Bed Bugs may also harbor in areas of the room away from the bed. Apply as a crack-and-crevice or spot application where evidence of bed bugs occurs. This includes bed frames, box springs, inside empty drawers and clothes closets, night stands and other furniture in the room, carpet edges, high and low wall moldings (such as floor molding or window casings), wall voids, behind wall hangings and mirrors, wall paper edges and popcorn ceilings. Remove all clothes and other articles from dressers or closets before application. Allow all treated areas to dry thoroughly before use.

[Notes to Reviewer] (Optional Language)

The key to solving a bed bug problem is early detection. Be watchful for signs of an infestation like skin bites or small spots of blood on sheets or pillowcases. After mattress treatment, purchase a high quality mattress encasement so the mattress doesn't need to be retreated. Before treatment, wash linens, bed covers and curtains using hot water; dry items using the high heat setting. Store treated or uninfested items in sealed plastic bags to avoid a future infestation. Clean and vacuum well before treatment to remove as many bugs as possible. Stay vigilant; repeat applications may be needed over the next 2 months.

To Kill Carpenter Ants: Apply around doors, door frames, windows, and other areas where Carpenter Ants enter the premises or hide. Spray into cracks and crevices, through openings, or into small newly drilled holes into wall voids where these ants or their nests are present.

To Kill the Accessible Stages of Granary Insects: Rice Weevils, Confused Flour Beetles, Rust Red Flour Beetles, Saw-toothed Grain Beetles, Cadelles, Meal Moth Larvae and Adults, Cigarette Beetles, Drugstore Beetles, and Granary Weevils: Apply to surfaces where these pests are normally found, such as floors and baseboards and around walls. Pay particular attention to cracks, crevices, and similar protected locations in floors and walls.

OUTDOORS:

((Turn)(Move)(Set)(Rotate) trigger (nozzle) to the (outdoor) (wide) (fan) (icon) setting))

To Kill Cockroaches: Apply to outside surfaces of buildings, porches, patios, garages and other areas where these pests are seen or found.

To Kill Flies and Mosquitoes: For outdoor use only as an aid in controlling these insects. Spray outside surfaces of screens, doors, window frames, or wherever insects may enter the room. Also spray surfaces around light fixtures, on porches, in garages and other places where insects alight or congregate. Repeat as needed.

To Kill Ants, Asian Lady Beetles, Brown Marmorated Stink Bugs (BMSB), Ticks (including ticks which transmit Lyme disease, Crickets, Fleas, Stink Bugs, and Earwigs: For treatment of infestation of these insects in areas where there are weeds or bushy non-crop areas, thoroughly spray infested areas. When treating for ticks, pay special attention to areas frequented by pets. For ants, thoroughly wet hills and runways.

Building Perimeter Treatment: To help prevent infestations of buildings by ants, Asian lady beetles, Boxelder bugs, Brown Marmorated Stink Bugs (BMSB), crickets, spiders, Mink bugs and sowbugs (pillbugs), treat a 12 - 18 inch band of soil or other substrate adjacent to buildings and the building foundation up to a maximum height of 3 feet above grade.
