

1. Separate baits before placement. Peel off and dispose of activation film.
2. For maximum effectiveness, all [2][3][4][5][6][7][8][10][12] baits should be used at one time. Baits should be spaced at 3 foot intervals.
3. For best results, place the baits on an even [flat] [level] surface touching the wall along baseboards, in corners, under sinks, in cabinets, near plumbing fixtures or wherever ants are present. Precaution: Avoid setting the bait station in direct sunlight to decrease evaporation of the gel bait [gel solution].
4. If ants are present, they will begin eating the bait in 3 hours and you should expect to see fewer ants in 14 days.
5. Replace baits weekly to keep ants from returning.
