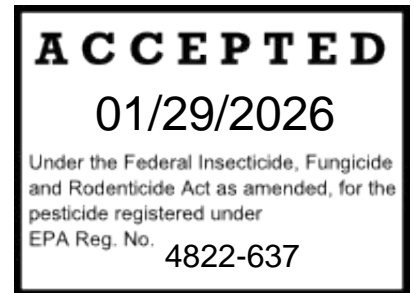

DIRECTIONS FOR USE

1. Open Pouch.
Tear open pouch and remove product. Product contains insecticide - handle by frame only.
2. Handle Safely.
Use hole on top of product to hang 2 m above the floor and at least 15 cm (6 inches) from a wall. Use product in every room. Product will reach efficacy 2 hours following placement. Wash hands with soap and water after handling. **KEEP OUT OF REACH OF CHILDREN.**
3. Place Product
Hang product from ceiling or 15 cm (6 inches) from the wall in regular rooms (30 m³). Place evenly throughout room. Wash hands with soap and water after handling.
**Use 1 product in smaller rooms (less than 15 m³) and 2 in rooms larger than 15m³.*
4. Replace Product
Replace after 1 year (365 days).

STORAGE AND DISPOSAL

STORAGE:

Store in a cool, dry area in its original sealed packaging until needed for use. Do not contaminate water, food or feed by storage or disposal.

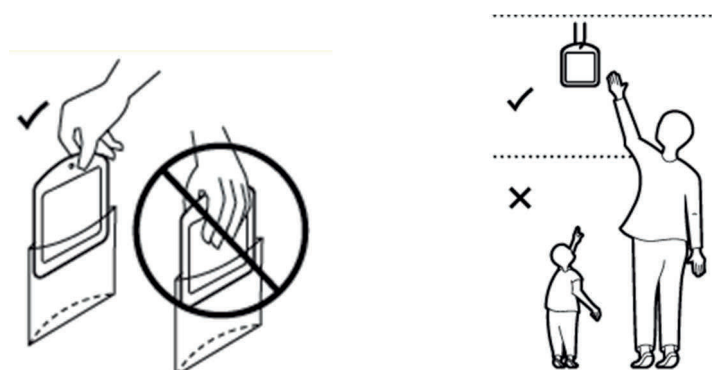
