**GENERAL CLASSIFICATION**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**Q-14 Disinfectant** is a proven "one-step" cleaner-disinfectant-sanitizer-fungicide-virucide in the presence of moderate amounts of organic soil.

Apply **Q-14 Disinfectant** to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

**Disinfection** -- to disinfect hard non-porous surfaces, add 1/2 oz per gallon of water. Treated surfaces must remain wet for 10 minutes. At this use-level, **Q-14 Disinfectant** is also virucidal and fungicidal.

**Sanitizing** -- To sanitize porous and non-porous contact surfaces, add 1/2 oz per gallon of water.

1/2 oz per gallon use-level. The broad spectrum activity of **Q-14 Disinfectant** has been evaluated in the presence of 5% serum and found to be effective against the following by the AOAC Use-Dilution test:

- Pseudomonas aeruginosa
- Staphylococcus aureus
- Salmonella choleraesuis
- Escherichia coli
- Klebsiella pneumoniae
- Enterobacter aerogenes
- Salmonella schottmuelleri
- Streptococcus faecalis

**AOAC Fungicidal Test**

**Q-14 Disinfectant** is effective against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, shower and bath areas, exercise areas, dressing rooms, etc.

**Mildewstatic Performance.** At 1/2 oz/gallon, **Q-14 Disinfectant** will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

**Virucidal Performance**

At 1/2 oz per gallon use-level, **Q-14 Disinfectant** was evaluated in the presence of 10% serum and found to be effective against the following viruses: Herpes Simplex (a member of the virus family that causes infectious mononucleosis), Vaccinia (representative of the pox viruses), and Influenza A<sub>1</sub> (the Hong Kong flu virus) on inanimate environmental surfaces.

**Sanitizing-Non-Food Contact Surfaces** (such as floors, walls, tables, etc.) At 1/2 oz per 2 gal use-level 30 second contact time **Q-14 Disinfectant** is an effective sanitizing agent in waters of up to 600 Lom hardness against Staphylococcus aureus and Klebsiella pneumoniae in the presence of 5% serum on porous and non-porous environmental surfaces.
