RAZE

An immediate acting - Residual type insecticide.

Flushes insects out of cracks and crevices, and into the spray. Provides immediate visual evidence of the effectiveness of the spray.

RAZE is an oil based Insecticide for indoor application as a surface spray. Spot treatment is made for control of crawling insects-cockroaches, ants, spiders, silverfish, crickets, clover mites, earwigs, carpet beetles, scorpions, box elder bugs and brown dog ticks.

RAZE will be effective against flying insects -house flies, wasps and mosquitoes when they rest on surfaces covered by the deposited residue from previous surface treatment.

DIRECTIONS

Cover foods and utensils used for foods. Use a coarse spray in cracks and crevices. Apply enough RAZE to wet surface without any run off of the spray.

Insects hit by the RAZE spray will be killed, while others will be killed when they rest on the residual deposit. Repeat in 2 to 4 weeks or when needed.

CAUTION

Harmful if swallowed. Avoid breathing of spray mist. Avoid contact with skin. Wash thoroughly after use. Avoid contamination of food and foodstuffs.

Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.
