

For this application around homes, resort areas, parks, industrial plants, hospitals and other areas, apply at the rate of 1¼ gallon to 7½ quarts per acre as a fog or mist for best results. Use the 7½ quart rate where shrubbery is dense.

Do not spray on food or feed crops. Repeat as often as necessary to obtain control.
