WKM-7 provides good results on fairways, but should not be used on golf greens or tees.

WKM-7

WKM-7 is effective on the following weeds: Dandelions, Clover, Common Chickweed, Mouse-ear Chickweed, Plantain, Pigweed, Ragweed, Lambs-quarters, Knotweed, Black Medic, English daisy, Dock, Purslane, Wood Sorrel and Mallow.

Directions: Apply when weeds are young and actively growing. Apply only when soil is very moist, following a good rain or thorough watering. Do not water for at least 24 hours after application of WKM-7. If it should rain during this 24 hour period, efficiency may be reduced, but wait for at least 7 days to determine whether another application is necessary.

Use equipment which applies product uniformly, such as a boom type sprayer. For best results, and since WKM-7 is absorbed through the leaf area, avoid cutting or mowing turf for at least 1 or 2 days before or after spraying.

For established turf, apply at a rate of 1 1/2 fluid oz. in 1 to 2 gals of water per 1000 sq. ft. or 4 pints of WKM-7 in 50 to 40 gals. per acre. Determine the amount of water and WKM-7 to be used. Fill the tank of the clean spray equipment partially full with clean water, add WKM-7, mix thoroughly and add the balance of the water. Full effect of a WKM-7 application may not be visible for about three weeks.

Do not use on currently growing or mowed lawns. Avoid the use of this product when it is indicated on the label. Never consume all of it, and/or handle it in any manner when such is indicated in conformity to label instructions.

CAUTIONS

HARMFUL IF SWALLOWED. AVOID CONTACT WITH SKIN, EYES OR CLOTHING. AFTER USE, WASH HANDS AND OTHER PARTS OF BODY CONTAMINATED WITH CONCENTRATE, SPRAY OR WASHINGS.

Do not apply when wind is blowing and do not allow spray to drift to any other plants such as flowers, shrubs or vegetables as WKM-7 is a plant killer. Coarse sprays are less likely to drift. Do not use on new grass seedlings until they have developed to stage of first mowing. Do not use grass clippings from first mowing after treatment as a mulch for flowers or shrubs.

Do not apply during period of drought without first watering thoroughly. Do not apply when temperatures are extremely high. Grass may become discolored or injured if this product is applied in very hot weather (over 90°F).

Do not contaminate irrigation ditches, lakes, ponds or streams with concentrated solution, spray or spray washings. Do not use same spray equipment for other purposes unless cleaned with a good chemical cleaner, suitable for the purpose. Store in tightly closed containers, away from fertilizers, insecticides, fungicides, seeds, plants and water supplies.

Protect from freezing. Do not reuse empty container. Wash thoroughly with water and detergent. Discard in a safe place.
