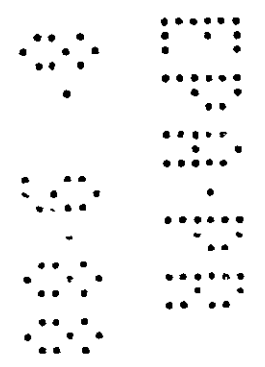

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

READ ENTIRE LABEL BEFORE USING.

**URINAL CLEANING:** First pour Bowl Cleaner over mop allowing excess to drain into basin of urinal. Then clean all parts of urinal thoroughly, making sure all indentations, water outlets, and grooves are reached. To deodorize, remove basin outlet screen and pour 1 to 4 ounces of solution into and around the area allowing solution to flow into drain pipe. Swab all parts completely including inside of pipe outlet. Replace screen, flush urinal and rinse thoroughly all parts to which this product has been applied.

**TOILET BOWL CLEANING:** Use 1 to 4 ounces per bowl. First remove excess water by forcing it over trap with a mop. Then press mop free of excess water. Draining into the toilet bowl, pour Bowl Cleaner over mop and thoroughly clean all parts. Be sure to reach under the rim at water outlets. Swab entire bowl, seat and cover with solution. After cleaning and disinfecting, completely rinse every part to which Bowl Cleaner has been applied.

**CAUTION:** Use only on acid-resistant toilet bowl and urinal surfaces.

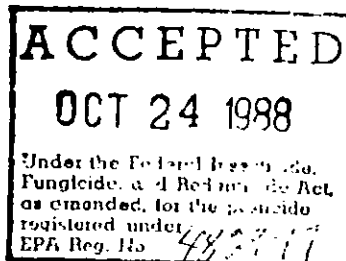

STATEMENT OF PRACTICAL TREATMENT
