Dear Ms. Hoffmann:

This is in response to your proposed general revision and update of your label.

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy of the labeling is enclosed for your records. Five copies of the finished labeling must be submitted before the product is released for shipment.

- The Statement of Practical Treatment must be on the front panel (rather than just referenced on the front panel).
- In the Storage and Disposal section, add the following pesticide disposal text (in accordance with PR Notice 83-3):

Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Posticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconisstent with its labeling.

Uisng a test kit, adjust the pH of the pool water, if necessary, to the pH range of 7.2 to 7.6. If the pH is below 7.2 add pH Plus. If the pH is above 7.6, add pH Minus. Once-A-Week Tarry Long-Lasting Individualized Chlorinating 8 oz. Tablets are intended for use in a Coastal tablet dispenser, an automatic in-line chlorinator, or other similar dispensers or in-line feeders. Adjust the chlorine dispensing rate of the dispenser or feeder to provide a chlorine residual of 1.0 to 1.5 ppm (parts per million). A suggested dosage is one tablet per 11,500 gallons of water per week. This dosage may vary due to unusual conditions such as heavy bather load, wind, heavy rains or high temperatures. If those conditions exist, frequent use of a test kit is recommended. Do not add these tablets directly to the pool or mix with any other chemicals.

### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

STRONG OXIDIZING AGENT. Mix cally with water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire and explosion. Contamination with moisture, organic matter or other chemicals may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible generation of fire and explosion. In acse of contamination or decomposition, do not reseal container. Ioslate container (if possible) in open air or well ventilated area. Flood with large volumes of water to dissolve all material before discarding container.

#### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless this product is specifically identified and addressed in an NPDES permit Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. #### STORAGE AND DISPORAL

Keep this product dry in a tightly closed container when not in use. Score in a cool, dry, well ventilated area away from heat and open flame. In case of decomposition, do not reseal container.
