This is in response to your registration amendment submissions for label revisions and updated Confidential Statements of Formula.

The amendments referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, are acceptable subject to the comments listed below. A stamped copy of each product's labeling is enclosed for your records. Five copies of each product's finished labeling must be submitted before the product is released for shipment.

1. The Statement of Practical Treatment must be on the front panel (rather than just referenced on the front panel).

2. In the Storage and Disposal section, add the following pesticide disposal text (in accordance with PR Notice 83-3):

Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

3. For each of the subject products, in order to declare 63.0% Trichloro-s-triazinetrione, the Confidential Statement of Formula (CSF) must indicate 63.7% in item 13(b). The percentage inert ingredients must also be revised accordingly, as well as the amounts in 13(a). Submit a revised CSF for each product.

4. In your revised CSFs, make sure to enter upper and lower certified limits in items 14(a) and 14(b). Note that for the active ingredient, the lower certified limit must be the same as the percentage on the label.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

START-UP:

When starting up a reopened or freshly filled swimming pool, make sure that the filtration system is clean and operating properly. Adjust and maintain the pH in the range of 7.2 to 7.6. Use Coastal pH Plus or pH Minus as indicated by a test kit. Then superchlorinate with either a shock treatment or stabilized chlorinating granules to establish a positive ree chlorine residual of 1.0 to 1.5 ppm (parts per million). Raise the cyanuric acid vel, if necessary, to 35 ppm by adding Coastal Chlorine Stabilizer, following label directions.

DAILY:

Add Tab-A-Day Fast Dissolving Chlorinati Tablets to the pool skimmer as necessary to maintain a 1.0 to 1.5 ppm (parts per million) chlorine residual. A suggested dosage is one Tab-A-Day Fast Dissolving Chlorinating Tablet per 7,500 gallons (daily). This dosage may vary due to unusual conditions such as heavy bather loads, wind, heavy rain and high temperatures. Therefore, frequent use of a test kit is recommended as a guide to maintain the chlorine residual at 1.0 to 1.5 ppm and the pH at 7.2 to 7.6.
