

HAZARDS TO HUMANS AND DOMESTIC ANIMALS.

DANGER: Highly Corrosive. Causes skin and eye damage. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Irritating to nose and throat. Avoid breathing dust. Remove and wash contaminated clothing before reuse.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not discharge into lakes, streams, ponds or public waters unless in accordance with an NPDES Permit. For guidance, contact the regional office of EPA.

PHYSICAL AND CHEMICAL HAZARDS

STRONG OXIDIZING AGENT: Mix only with water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter, or other chemicals may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible generation of fire and explosion. In case of contamination or decomposition, do not reseal the container. If possible, isolate container in open air or well ventilated area. Flood with large volumes of water if necessary.

PRACTICAL TREATMENT

FIRST AID: If swallowed, feed bread soaked in milk followed by olive oil or cooking oil. Call a physician immediately. If on skin, brush off excess chemical and flush skin with cold water for at least 15 minutes. Irritation persists, get medical attention. If in eyes, flush with cold water for at least 15 minutes. Get medical attention.

STORAGE AND DISPOSAL:

Keep product dry in tightly closed container when not in use. Store in cool, dry, well ventilated area away from heat or open flame. In case of decomposition, isolate container if possible and flood with large amounts of water to dissolve all material before discarding. Place in trash collection or dispose in approved landfill area or bury in safe place.

AVAILABLE CHLORINE CONTENT IS 56%.

Tab-A Day Fast Dissolving Chlorinating Tablets provides effective control of bacteria and algae growth in pool water. Do not add this product directly to pool water or to continuous tablet chlorinating devices. Tab-A Day Fast Dissolving Chlorinating Tablets are intended for addition to the pool skimmer or into a floating dispenser. Do not mix this product with any other chemicals.

DIRECTIONS FOR USE

START-UP: When starting up a reopened or freshly filled swimming pool, make sure that the filtration system is clean and operating properly. Then adjust and maintain the pH in the range of 7.2-7.6. Use Coastal pH Plus or pH Minus as indicated by a Coastal Test Kit. Then Superchlorinate with either Shock Treatment or Stabilized Chlorinating Granules to establish a positive free chlorine residual of 1.0-2.0 parts per million (ppm). Raise the cyanuric acid level, if necessary, to 50 ppm. By adding Chlorine Stabilizer, see following directions for that product.

DAILY: Add Tab-A Day Fast Dissolving Chlorinating Tablets to the pool skimmer as necessary to maintain a 1.0-2.0 ppm chlorine residual. A suggested dosage is one Tab-A Day tablet per 5,000 gallons daily. This dosage may vary due to unusual conditions such as heavy bather loads, wind, heavy rains, and high temperatures. Thereafter, frequent use of the Test Kit is recommended as a guide to maintain the pH at 7.2-7.6 and the chlorine residual at 1.0-2.0 ppm.
