

DIRECTIONS FOR USE

I-Deen-2 is an iodophor type cleaner specifically designed to be effective for a wide range of applications in hospitals, homes, motels, and schools. I-Deen-2 has a built-in color indicator of sanitizing activity. When the amber color fades, a fresh solution should be prepared.

To disinfect walls, floors, and pet cages, first remove gross contamination. Thoroughly wet surfaces with a solution consist- of 3 oz. of I-Deen-2 to 5 gallons of water. Scrub area with a brush, sponge or rag. Rinse. All food handling equipment disin- fected with similar solution should be rinsed with potable water.

NO-RINSE REGULATION

Previously washed and rinsed glasses, food processing equipment, and utensils may be sanitized with a solution of 1 oz. of I-Deen-2 per 5 gallons of water (providing 25 ppm titratable iodine). When used in this manner, I-Deen-2 does not require a final potable water rinse as prescribed in Federal Food Additive Regulation 121.2547.

Rinse empty container thoroughly with water and discard it.

WARNING
