DIRECTIONS FOR USE

Apply when the air is calm, using a hand or power duster or fertilizer spreader.

ORNAMENTAL TURF: For control of earwigs, millipedes, centipedes, fleas, ants, army worm, leafhoppers and sod webworms. Apply at the rate of 10 $\frac{1}{2}$ per 5,000 sq. ft. of lawn. Apply evenly and uniformly over the lawn area.

ORNAMENTALS (Flowers, shrubs & shade trees): For control of bagworm, boxwood, oak and birch leaf miners, boxelder bug, Japanese beetle, elm leaf beetle and aphid, flea beetles, plant bugs, lace bugs, leafhoppers, scale insects, rose aphid and slug, tent caterpillars, gypsy moth, and periodical cicada. Apply a thin even coat of dust to the foliage, paying particular attention to coating the underside of the leaves.

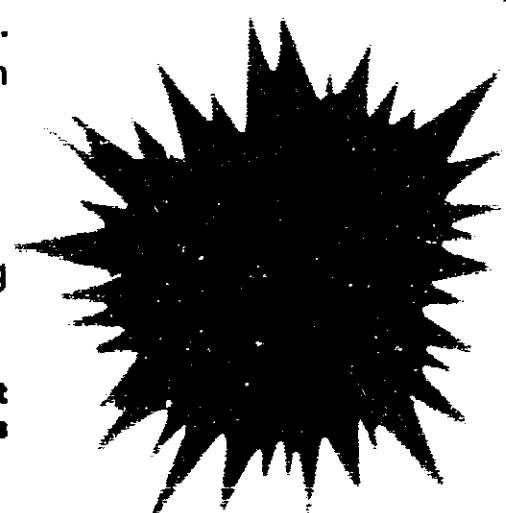
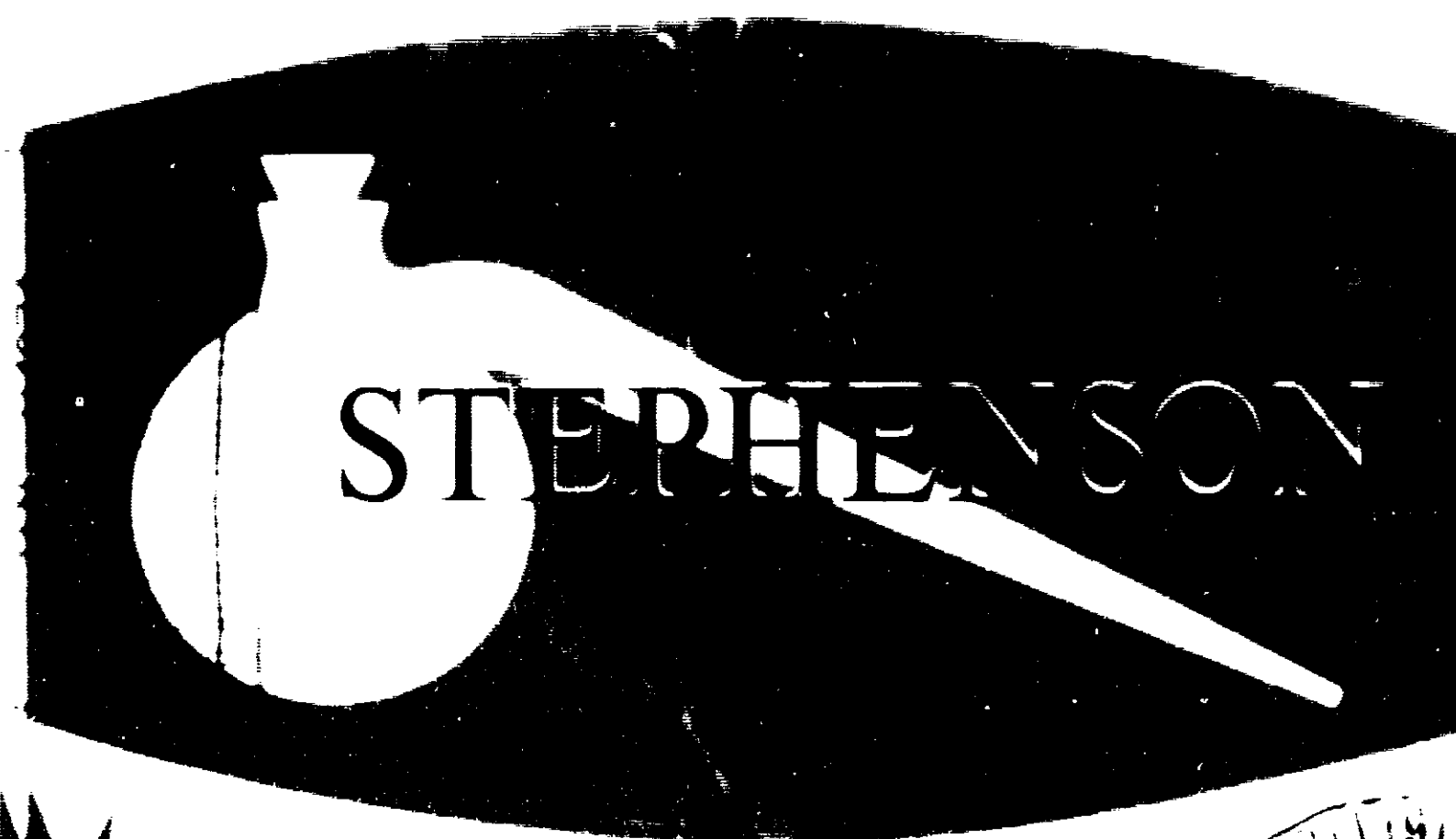
