
DIRECTIONS FOR USE:

To control roaches, ants, waterbugs, spiders, crickets, silverfish. Spray or apply liberally with brush, on shelves or wherever these insects hide or breed. Apply to baseboards, around window sills, door sills, under sink and around pipes under stoves and all cracks in bookcases, shelving and storage areas. Repeat treatment as required.

To control flies, flying moths, wasps, mosquitoes, June bugs, scorpions, box elder bugs. Use outdoors only by spraying or brushing until wet, outside surfaces of screens, window frames, door frames or in cracks, wherever insects can enter the house. Treat surfaces around light fixtures on porches, garages, or any other spots where insects are attracted and alight.

Silverfish

To control carpet beetles, ants, silverfish, spray or brush on infested areas of floor and baseboard, being sure to use enough Dizon to thoroughly wet to bottom of cracks. Apply as needed to floor under carper and wherever these insects hide and breed. Apply on the undersides of carpets where carpet beetles are found. Repeat as necessary.
