For the control of many flower insects and fungus diseases. Clean, healthy flowers when you use GOOD-LIFE FLOWER GARDEN SPRAY OR DUST.

SPRAY APPLICATION: DIRECTIONS:

Mix 4 ounces (8 tablespoonsful) FLOWER GARDEN SPRAY OR DUST in a mason jar or similar container with enough water to make a heavy paste. Stir thoroughly until mixture is well creamed and smooth. Dilute with water and pour into sprayer. Add water to make 2 gallons of solution. Be sure to keep mixture agitated by giving sprayer a good shake once in a while to avoid chemical settling out. Spray flowers and foliage of plants thoroughly (topside and underside of leaves.)

IMPORTANT:

Spray plants as soon as well rooted, repeat at intervals of 10 days to 2 weeks. After rain washes FLOWER GARDEN SPRAY OR DUST off the plant, do not delay in putting on a fresh application. Remember that it is always best to kill insects when they are young, and prevent fungus disease, rather than try to cure it.

DUST APPLICATION: DIRECTIONS:

FLOWER GARDEN SPRAY OR DUST should be applied early morning or in evening when air is still.

Use dust gun or duster to apply dust thoroughly to entire plant, being sure to cover both lower and upper leaf surfaces.

Regular applications at intervals of not to exceed 2 weeks should provide excellent control, however, when rain washes the plants clean, a fresh application of dust should follow as soon as plants are dry.

GOOD-LIFE FLOWER GARDEN SPRAY OR DUST may be used on the following flowers: Aster, Azalea, Camellia, Crepe Myrtle, Chrysanthemum, Columbine, Dahlia, Delphinium (Larkspur), Gladiolus, Iris, Peony, Phlox, Tulip, Lily, Narcissus, Calendula, Cannas, Carnation, Cosmos, Golden Glow, Hollyhock, Marigold, Morning Glory, Nasturtium, Pansy, Petunia, Roses, Snapdragon, Sweet Pea, Verbena, Violets, Zinnias.

Shrubs: Forsythia, Hawthorne, Honeysuckle, Hydrangea, Snowball, Spirea, Virginia Creeper, Wisteria, Barberry, Boxwood, Dogwood, Lilac, Mock Orange, Privet, Rhododendron.

GOOD-LIFE GARDEN SPRAY OR DUST will control many insects, including the following: Bagworms, Blister Beetles, Boxwood Leaf Miner, Flea Beetles, Japanese Beetles, Aphids, Birch Leaf Miner, Four-Lined Leaf Bug, Lace Bugs, Leafhoppers, Mealy Bugs, Tarnished Plant Bug, Whitefly, Rose-Slug, Thrips (exposed), Tent Caterpillar, Leaf Rollers, Plant Bugs, Rose Aphid, Azalea Scale, Black Scale Crawlers, Euonymus Scale, Fletcher Scale, Florida Red Scale, Juniper Scale, Leaf Scale, Magnolia Scale, Monterey Pine Scale, Oyster Shell Scale, Scurfy Scale, Soft Brown Scale, Spider Mites.

Also controls most common fungus diseases such as black spot, on roses, rust and leafspot on carnations and flower blight on Chrysanthemums.
