DIRECTIONS FOR USE:

USE ON FRUITS	DISEASE OR FUNGI	DOSAGE AMT PER GAL./ WATER	TIME
Cherries (sour)	Leaf Spot	2.5 Tbsp.	Apply in popcorn, full bloom & petai fall stages, 2-3 weeks before harvest & 2 post harvest foliage sprays.
Grapes	Anthracnose Black Rot Downy Mildew	9 Tbsp.	Begin when new growth is ½" long, repeat at 2 week intervals, before and after bloom when grapes are size of buck- shot, and 2 weeks later.
Apples	Anthracnose Bitter Rot Blotch Scab	9 Tbsp.	Apply in cover sprays. Apply in prepink and pink stages and in cover sprays as required.
Gooseberries Currants	Anthracnose	6½ Tbsp.	Apply after leaves open.
VEGETABLES Potatoes	Early & Late Blight	9 Tbsp	Apply when plants are 4-6 in. high, re- peat every 7-14 days.
Tomatoes	Anthracnose Early & Late Blights, Leaf Spots	6 Tosp.	Apply when plants are set out, re- pesting 7-14 days.
Cantaloupes Cucumbers Squash Watermelon	Angular Leaf Spots Anthracnose Downy Mildew Leaf Blights, Scab	4 Tbsp.	Apply when plants begin to vine, re- peat 7-14 days as necessary.
Beans	Angular Leaf Spot Anthracnose Blight Downy Mildew	4 Tbsp.	Apply before disease is expected to appear, repeat 7-14 days as necessary.

Linden Maples Sycamore Elm	Anthracnose Leaf Spot	4 Tosp.	Apply as leaves unfold in spring. Repeat in 2-3 wks.

CAUTION

Bordeaux Mix is not recommended for early application to variaties of apples susceptible to russeting. Injury to curcurbits and some other crops may occur under certain conditions.
