
- Under the "Ingredient" Statement delete the "s" on "Active Ingredients".

STORAGE AND DISPOSAL

Keep container closed when not in use. Do not store below 20° F or above 100°F for extended periods. In case of spill, flood area with large quantity of water. Product or rinsates that cannot be used should be diluted with water before disposal in a sanitary sewer. Do not reuse container, but place in trash collection. Do not contaminate food or feed by storage, disposal or cleaning of equipment.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

- Not to be used as a teat dip.

FOR USE AS AN UDDERWASH:

NOTE: The laws in some states require that the sanitizing solution remain in contact with the surface for two minutes. Follow the recommendations of your health department.

- Always use fresh solution.
- Prepare a wash solution using 1 ounce of CLEAN Sanitizer and Udderwash to each 5 gallons of lukewarm water (100°F). This solution contains 25 ppm titratable iodine.
- Dip a single service paper or cloth towel into wash solution and wash teats to the base of the udder.
- Forestrip.
- Dry teat with individual paper or cloth towel. Attach milker unit.
- Prepare a fresh solution if wash solution fades noticeably or becomes diluted or soiled.

FOR SANITIZING DAIRY EQUIPMENT AND UTENSILS:


- Wash the equipment to be sanitized using a manual cleaner, following label instructions. Rinse with potable water and drain.
- Prepare a wash solution using 1 ounce of CLEAN to each 5 gallons of water, or add ½ ounce of sanitizer to a 10 quart pail of water. This solution contains 25 ppm titratable iodine.
- Immerse equipment (milking claws, lines, teat cups) into solution, making sure that all surfaces are in contact with the solution. A contact time of 1 minute is required.
- For equipment that cannot be immersed (bulk coolers, receiver groups, etc.), spray a 25 ppm iodine solution onto all pre-cleaned surfaces for a sparkling, spot-free shine.
- Allow solution to drain and air-dry.
- Prepare a fresh solution daily or more frequently if sanitizing solution fades noticeable or becomes diluted or soiled.
- CLEAN Sanitizer and Udder Wash has its own indicator of germicidal activity. The amber or yellow color shows the presence of the active ingredient—iodine.

PRECAUTIONARY STATEMENT: HAZARDS TO HUMANS AND DOMESTIC ANIMALS.

FIRST AID:

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a Poison Control Center or doctor for treatment advice.

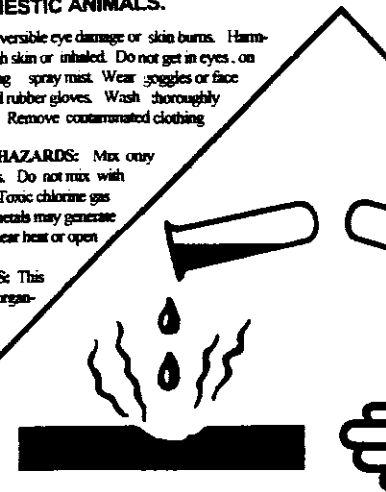
IF SWALLOWED: Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the Poison Control Center or doctor. Do not give anything to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a Poison Control Center or doctor for treatment advice.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. You may also contact 1-800-424-9300 for emergency treatment.
