The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped "Notification" and will be placed in our records.

DIRECTIONS FOR LISE:

At a use dilution of 1 oz. to 2 oz. per 5 gal. of water, Acidet[®] Acid Sanitizer provides 300 - 600 ppm of dodecylbenzenesulfonic acid. On precleaned food contact surfaces, Acidet[®] Acid Sanitizer is effective against Salmonella cholerasuis, Listeria monocytogenes and Escherichia coli, 0157:H7, Hemorrhagic.

FARM USE

For Milk Claws and Inflations: Clean with a suitable detergent and rinse with potable water. Flush an Acidet[®] Acid Sanitizer solution of 1 oz. to 2 oz. per 5 gal. of water (equivalent to 300 - 600 ppm of dodecylbenzenesulfonic acid) through the system. Do not recirculate.
