DIRECTIONS FOR USE

GENERAL: Spray surface to wetting. Always spray away from people, plants and pets. Do not use as a space spray. Use only for spot treatment.

TO KILL ANTS, ROACHES, CRICKETS, SILVERFISH, BOWLINGS, SPIDERS AND EARWIGS: Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and around waste containers. Contact directly as many insects as possible. For ants, spray trails and places where ants enter premises. Repeat as necessary for control.

TO KILL FLEAS IN CARPETS AND RUGS: First, vacuum carpet or rug to be treated thoroughly. Be sure to discard contents of vacuum cleaner in such manner as to prevent re-infestation. Spray surface to slight dampness. Do not saturate. Holding can 18" to 24" above area to be treated, spray with a sweeping pattern back and forth to insure complete coverage. Deep pile or shag rug brush one direction, spray, brush opposite direction if an spray to assure deep thorough penetration. Spray along baseboards, window and door frames, wall cracks, and local areas of floor. Open windows and allow to air dry for at least two hours. Do not use on upholstered furniture.

KEEP ALL CHILDREN, ADULTS AND PETS out of area until completely dry. Re-vacuum treated area after carpet or rug is dry. Repeat treatment as necessary.

FOR PET AREAS AND SLEEPING QUARTERS: Remove and destroy old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as necessary. Fresh bedding should be placed in animal quarters after spray has dried. Do not spray animals.

TO KILL CARPET BEETLES AND DERMEESTIDS: Spray along baseboards, edges of carpeting, under carpets and rugs, under furniture, in closets, on shelving, and in other places of harbourage. Repeat as necessary.

CAUTION: KEEP OUT OF REACH OF CHILDREN

May be harmful if swallowed, inhaled or absorbed through skin. Avoid inhalation of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes and clothing should be avoided. Wash thoroughly with soap and water after handling. Do not use in edible products areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Remove pets and cover fish bowls before spraying. If poisoning occurs, get prompt medical aid.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

WARNING: Flammable. Contents under pressure. Do not use near fire, sparks, or flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.
